#### AED Equipment: PLEASE NOTE:

- On the departmental report out, head coach Mike Mason had asked the question as to who will have the SCRC AED and will that be provided to the adult training group?
- The board of directors agreed that the SCRC AED will be held in Heidi Ryan's car and not on the course with the adult training coaches. We currently do not have a SOP procedure and recertification of the AED equipment that is made known to the adult training coaches. Therefore, all emergencies will be directed to Heidi Ryan, membership director, as she will be the keeper of the AED.
  - $\circ$   $\;$  First one to come upon the situation makes the call.
  - Second, Dial 911 if needed
  - Third, Dial Heidi Ryan's number if you dialed 911 (AED will be in her car and she will be responsible to getting fast access to the trainee down in the park)
  - Fourth, Dial Head Coach Mike Mason or Susan Taylor (They will not have the AED on the bike trailer roving first aid).

### Race Series Update:

We have ordered approximately 135 medals to cover off the race series with 125 who are eligible. We are seeing a couple of situations in which virtual runners are not listed in the data base for some races. When this is bought to our attention we are correcting – so far we only have identified about 4 of these instances.

The medals are still on time to get here before the first week of October.

- Adult Training/Run Signup & Membership Signup Data Base

Mike Mason is moving to digital signups for the trainee group. He is proposing a fee increase to include the processing costs. (Membership has already had a signup process through active but not verifying membership up against the trainee group. Runsignup which is highly recommended by RRCA has controls in place that will oversee the general membership population for SCRC. Mike Mason has agreed to help Heidi with the online membership signup to try to automate the process of membership and training team signups. We all have been keeping an open dialog of what works and what does not. The objective is to save time, energy and improve upon the financial controls of intake and payment summaries back to the club. It was agreed that we would still allow for any manual signups, but those would have to be entered manually into the Runsignup data base. Runsignup will now be the official data base for our members. However, we are still recommending a parallel system (Heidi's spreadsheet) to run with online signup as to ensure that we don't lose any continuity.
